There is good cause to believe that immediate and irreparable damage to the Court's ability to grant effective final relief for consumeriscluding monetary restitution, rescission, or refunds—will occur from the sale, transfer, destruction, or other disposition or concealment by Defenda8mith of his Assets or records, unless Defendamith is restrained and enjoined by order of this Court.
 - I. Good cause exists for continuo to freeze Defenda Smith's Assets.
 - J. This Order is in the public interest.
- K. This Court has authority to issue this Order pursuant to Sections 13(b) and 19 of the FTC Act, 15 U.S.C. §§ 53(b) and 57b; Federal Rule of Civil Procedure 65; and the All Writs Act, 28 U.S.C. § 1651.
- L. The FTC is an independent agency of the United States, and no security is required of any agency of the United States in connection with issuance of a preliminary injunction. Fed. R. Civ. P. 65(c).

DEFINITIONS

For the purpose of this Order, the following definitions shall apply:

- A. "Asset means any legal or equitable interest in, right to, or claim to, any property, wherever located and by whomever held.
- B. "Corporate Defendant' means Business Revolution Group Inc., also d/b/a Joe Gaires, and each of its subsidiaries, affiliates, successors, and assigns.

- C. "Defendants' means the Corporate Defendant, Charles Joseph Garis, Jr., also d/b/a Joe Gaines, Samuel James Smith, also d/b/a Weblio, a/k/a Weblio Squeeze, and Robert William Shafer, also d/b/a Shafer MM&I, a/k/a MMI, individually, collectively, or in any combination.
- D. "Document' is synonymous in meaning and equal in scope to the usage of "document" and "electronically stored information" in Federal Rule of Civil Procedure 34(a), Fed. R. Civ. P. 34(a), and includes writings, drawings, graphs, charts, photographs, sound and video recordings, images, Internet sites, web pages, websites, electronic correspondence, including email and instant messages, contracts, accounting data, advertisement Logs, Server Access Logs, books, written or printed records, handwritten notes, telephone logs, telephone scripts, receipt books, ledgers, personal and business canceled checks and check registers, bank statements, appointment books, computer records, customer or sales databases and any other electronically stored information Documents located on remote servers or cloud computing systems, and other data or data compilations from which information can be obtained directly or, if necessariter translation into a reasonably usable form. A draft or non identical copy is a separate document within the meaning of the term.

Notifying any trustee, protector or other agent of any foreign trust or other related entities of either the existence of this Order, or of the fact that repatriation is required pursuant to a court orderuntil such time that Defenda8tmith's Assets have been fully repatriated pursuant to this Order.

IX. CONSUMER CREDIT REPORTS

1681b(a)(1), and that, upon written request, any credit reporting agency from which such reports are requested shall provide them to Plaintiff.
